## Birch Run Township Resolution for Street Lighting District – Evergreen Drive Resolution #2024-14

At a Regular Meeting of the Birch Run Township Board, Township of Birch Run, Saginaw County, Michigan, held at the Township Meeting Room on the 10<sup>th</sup> day of September 2024, at 7:00 p.m. Eastern Standard Time.

**PRESENT**: Watts, K. Kiessling, Letterman, Sheridan, D. Trinklein Jr., R. Kiessling, C. Trinklein, **ABSENT**:

The following resolution was made by K. Kiessling and seconded by D. Trinklein Jr.:

WHEREAS, the Birch Run Township Clerk received three petitions for the creation of a Special Assessment District (SAD) for Streetlighting within the Evergreen Drive Subdivision, whereby it is proposed to install twelve (12) 40W LED C Electric Streetlights and the recovery of the cost thereof by SAD against the property benefited therein, and

**WHEREAS**, the number of verified signatures on the petitions were determined to be signed by the record land owners whose residential units constitute more than 50% of the total land owners of the proposed SAD district described hereinafter, to initiate a public hearing process, and

**WHEREAS**, the proper notification of such a public hearing was published in the paper no less than 15 days prior to the hearing, along with notice being mailed to the real property owners of the proposed SAD no less than 15 days prior to the hearing, and

**WHEREAS**, during the September 10<sup>th</sup>, 2024, Regular Township Board meeting at 7:00 p.m. Eastern Standard Time, in the Birch Run Township Government Room at 11935 Silver Creek Drive, Birch Run, MI 48415, such a Public Hearing was held to hear comments and objections to the proposed street lighting, or the SAD described hereinafter and within the published and mailed notices, and

**AND WHEREAS**, the Township Board has received plans showing the improvements and locations thereof together with an estimate of costs of such initial administrative, professional, and construction work in the approximate amount of \$1,840 for the first year, and approximately \$1,802 for each subsequent year's energy billings, and

WHEREAS, said payments of the special assessment shall be adjusted from time to time to reflect actual energy and administrative costs for the street lighting provided, and that the Township Board has determined that the method used for justly calculating the costs to be assessed will be tied to the number of homes within the SAD which is currently 38 and subject to change with the addition of more homes, instead of the number of parcels,

**THEREFORE, BE IT RESOLVED**, by the Birch Run Township Board of Trustees, that the above noted Evergreen Drive Street Lighting Special Assessment District is hereby ratified upon the effective date of said agreement.
